**Procedures and Information**

The Lavender in the Village Festival is a family oriented event. While lyrics with swearing and a message, which encourages or condones violence, sexual harassment, sexual innuendos, use of drugs, degradation of persons due to race, gender, etc. may have its place in the media industry – **it does not comply with the vision of this Festival.** Please take into consideration as to whether this festival is one that will meet your needs and well as those of this event.

The Lavender in the Village Festival committee reserves the right to accept or reject any applications.

1. Performer shall be an independent contractor and not an employee of the Lavender in the Village Festival and/or Lavender in the Village of Los Ranchos de Albuquerque, Inc., under this agreement.
2. Each group performs a minimum of 2 hours, with one 15-minute break.  
Bands are expected to arrive at least 30 minutes prior to their scheduled start time.
3. **This is an outdoor event. Please be prepared accordingly.**
4. The Lavender in the Village Committee shall have overall control of content and sound levels of the performance. Your output levels should allow for conversation at 100 feet.
5. Electrical/sound requirements: The festival will provide 20 amps. Groups are responsible for insuring their performance equipment will not exceed the available power. Entertainers are required to provide all required elements (stands, power strips, music stands, stools and monitors). Additional lines required \_\_\_\_\_ for a total of \_\_\_\_\_ amps.
6. Security will be provided on Friday and Saturday evenings however the festival will not be responsible for damage, theft or loss of any entertainer's property before, during, or after performance hours.
7. Parking: Parking for one vehicle per booth in a designated area.
8. Additional information, such as booth assignments, maps, set-up/tear-down and other pertinent information will be mailed in June.
